
This Policy is operational since 2008. The objective of the scheme is to provide financial assistance to the meritorious students having less family income, to a part of their day-to-day expenses while pursuing higher studies. The Scholarships are awarded by PACE society based on the recommendations of the committee formed for the purpose. A maximum of Rs.2,50,000/- to nearly 20 students will be awarded scholarships every year.


Eligible criteria

1. Student those not getting Government another Scholarships are only eligible
2. Students studying in Vikas Institute of Pharmaceutical Sciences are only eligible to apply.
3. Students with low income group and merit is available.
4. Students should have bank account on their names to disburse the scholarship.

Procedure for application:

1. Students should apply online in vips website (vips.global) by 30th March every year.
2. Applications will be received by the principal and forward the same to Management committee.
3. Scrutinize application and interview the student applicants and finalize the list.
4. Received list forwarded to management for approval.
5. Management approved the list and budget and forward to principal for disburse of money.

IRF Awards, whose signatories will be any two of the office bearers e.g. the President, the Hon. Gen. Secretary and the Hon. Treasurer of IPA. IPA will provide an audited statement of accounts for expenses incurred during the year towards executing the awards to the Company within 30 days from the end of the accounting year every year. All surplus out of the Rs two lakhs allotted for IRF awards at the end of each accounting year will be carried forward. The Company may review the amount of Rs. 4.0 Lakhs to IPA for the IRF Awards from time to time at its sole discretion.

- (b) In all correspondence, brochures, advertisements and communication in any form related to the IRF Awards, scholarships etc., the name "IPA-Shri Ramanbhai B. Patel" shall be prominently and conspicuously mentioned.


The Committee


The Selection Committee for the awards & scholarships shall consist of the **IPA President** ex-officio as **Chairperson** and **CMD of the Company or his nominee** as ex-officio as **Co-Chairperson**. A maximum up to **seven members** shall be nominated by the **IPA Central Executive Council (IPA-CEC)**. These members need not be from among the office bearers/ IPA-CEC members. The members of the Committee shall have due regard and the need for specialized knowledge to assist the **IRF** in its objectives. Two members shall be nominated by the **Company**. The number of members should not exceed nine but may change if the Committee feels that it is in the best interest of the **IRF** to do so. The Hon. Gen. Secretary of IPA will be the **Member Secretary** of the Committee.

- The term of the office of the members of the Committee shall be for two years and with the possibility of extending it to a further term of two years.
- The Committee shall meet once in a year, if necessary twice in a year.
- The agreement will be reviewed at the end of five years and may be renewed based on performance and effectiveness of the agreement to the satisfaction of Company.

This agreement can be modified / cancelled at the sole discretion of the company.



- (iii) to promote the pharmacy education through Scholarships for Undergraduate students.


The Awards

In order to achieve these objectives, the IRF shall undertake the following,

1. IPA – Shri Ramanbhai B. Patel Foundation Life Time Achievement Award
(Criteria and guidelines – Annexure A)
2. IPA - Shri Ramanbhai B. Patel Scholarship for the Undergraduate Pharmacy students
(Criteria and guidelines – Annexure B)

The Means

- (a) The Indian Pharmaceutical Association (IPA) in perpetuating the objectives of IRF shall receive from the Company a sum of Rs. 4.0 Lakhs (rupees four lakhs) p. a. gross for executing the IRF Awards every year in the month of April/May. Two lakhs of this amount is for the purpose of giving two IRF lifetime achievement Awards and to cover all expenses that are incurred in executing IRF Award-related activities by IPA and two lacks is being given to IPA towards establishment costs of the organization. IPA will open a separate bank account in the name of

Section B-Criteria for selecting students for fellowship

The principal of each selected college should forward the name of one student who secured admission to B. Pharm first year to Indian Pharmaceutical Association and who fulfilled the following criteria

- The student secured admission through merit and genuinely in need of financial support.
- Should not have joined the college by paying capitation fees.
- Should possess a genuine government issued certificate stating that the student is from an economically poor category.
- Has secured higher marks than the other financially needy students joined that year.
- Is not a recipient of any financial support by way of fee reimbursement or merit scholarships by government or college management or any other private funding organizations.
- The student recommended should maintain regular attendance to all theory and practical classes and appear for all sessional, mid-term and final examinations.
- The selected student must pass all examinations with a good grade to be eligible to receive the fellowship in the next year of B. Pharm course.
- The student receiving the fellowship should not have any disciplinary actions taken against him.
- The principal of the college should send a recommendation along with a conduct certificate each year for disbursing the next year scholarship.

IPA – Sri - Ramanbhai Patel Scholarships for B. Pharm Students

Indian Pharmaceutical Association - Sri Ramanbhai Patel Foundation (IRF) has decided to institute scholarships to 25 meritorious but financially needy students who have joined B. Pharm four-year course in India each year starting from the academic year 2015-16. IPA will be involved in identifying 25 pharmacy colleges across the country using a set of criteria to select college listed under section A. IPA will communicate through its Education Division to the principals of the 25 identified colleges to send the details of one B. Pharm student, who took admission in the first year B. Pharm and the student must meet with all the criteria listed under section B. IPA will then forward the list of these 25 B. Pharm students recommended from the 25 selected pharmacy colleges to the Ramanbhai Foundation to issue cheques for Rs 25,000 to each of the student. These selected students will receive Rs 25,000 - each year during their 4-year B. Pharm course of study.

Section A: Criteria for selecting 25 colleges across the country

College of Pharmacy can be a Pharmacy College or College of Pharmacy, or a Department of pharmacy or an Institute of Pharmacy. The words Pharmacy and Pharmaceutical Sciences can be used interchangeably.

Colleges can be a part of

- Universities/Deemed Universities,
- Government colleges,
- Privately owned colleges.

Colleges must be

- PCI and AICTE approved,
- Affiliated to a recognized University,
- Located within India.

Colleges should not have been

- In the past 5 years derecognized by any statutory authority,
- Closed for a period due to any reasons of lack of students faculty or ordered by government.

Colleges should be selected one each from all the major cities and from states, which have a high density of pharmacy institutions. States with less number of colleges may be clubbed together to identify a single college among them. Another college from the same region may follow a college selected from a region every alternate year to give an opportunity to the neglected colleges of the region to participate in this initiative.

Annexure B

IPA - Shri Ramanbhai B. Patel Scholarship for the Undergraduate Pharmacy students

Eligibility: First year B. Pharm students – in the first year and there after till completion of graduation

A Scholarship amount of Rs.25, 000/- to each selected student per year, for 4 years


Criteria:

Scholarship to under privileged students, who are financially needy to continue their pharmacy education

Guidelines

The scholarship will be called "The Indian Pharmaceutical Association – Shri Ramanbhai B. Patel Foundation (IRF) Scholarship for undergraduate pharmacy students:

- a) Announcement will be made through the Principal of the respective colleges during July / Aug / Sept in each year by the Hon. Gen Secretary.
- b) IPA will select 25 Pharmacy colleges located all over India, using a set of criteria or guidelines developed before Dec 2014 (Annexure C). After selecting the colleges, the Hon. Gen. Secretary will inform the college principals to select the candidate and facilitate the application for scholarship. The selection criterion for the student also will be developed shortly (Annexure D) and sent to the selected institutions. For the first year of its inception, the scholarships will start before end of academic year 2014 - 15
- c) Nominations for the grant of scholarship to undergraduate Pharmacy students shall be invited by the **Member Secretary, IRF in July / August/ Sept.** by giving six weeks time for receiving the nominations.
- d) Nomination should be submitted to the Member Secretary, IRF by the Principal of the selected college with a note justifying the nomination.
- e) The Principal of the selected college should submit only one nomination of a student admitted that year in first year B. Pharmacy course
- f) Scholarship will be distributed once a year
- g) The candidate should provide his/her bank account number and the name of the Bank with complete address.
- h) The scholarship amount should be utilized only for the payment of college fees/ purchase of educational books or for any related educational purposes.
- i) The amount of Scholarship will be Rs. 25,000 per student per year. The scholarship amount will be reviewed from time to time
- j) Initially, the scholarship will be given to 25 pharmacy students in a year.
- k) The amount will be sent directly to the selected candidate at the address provided by the college but not to the college. The amount will be paid by cheque/ Demand Draft/ RTGS.
- l) If the selected candidate fails the annual examinations anytime during the first three years of the B. Pharm course of study, the scholarship will be discontinued there after.
- m) The candidate should provide each year's marks-sheet along with the request for continuing/ extending the scholarship for the following year through the Principal.
- n) Any disobedience or complaints from the principal during the study period will lead to termination of the scholarship at the discretion of the IRF.
- o) Such terminated Scholarship may be transferred to another deserving student in need of financial support upon receiving a recommendation with justification from the Principal.
